# **Course Overview (QM Standards 1.2)**

#### **Course description:**

This class provides the student with techniques for employing ethics in law enforcement. Ethical clarity is especially critical for the police professional – perhaps uniquely so – because the ethical point of view determines the way "police competence" is understood. In addition to the Law Enforcement Code of Ethics, this course promotes an "ethic to live by" for officers and other professionals, and applies various schools of ethical thought to practical examples in policing. This course will provide the tools necessary for making intelligent, impartial decisions from a positive perspective.

This eight week course schedule will be broken into four Learning Modules with multiple parts for ease of access. Each Module will offer students opportunities to test their knowledge through interactive exercises, assessments, and quality discussions. In additional to the primary learning outcomes, students are encouraged to expand their knowledge on homeland security issues and the ever changing current events of our country.

#### **Course Goals and Objectives:**

- · Identify and explain the ethical systems covered in the text and in class
- Explain the psychological theories of moral development covered in the text and in class
- Identify and explain the moral and ethical issues facing police officers, corrections officers, prosecutors, and defense attorneys
- Given scenarios, demonstrate the ability to identify and resolve ethical issues
- Identify from current events ethical issues in criminal justice
