

RCJU305 — Civil Liabilities Master Course Syllabus

Course Overview (QM Standards 1.2)

Civil Liability is an 8 week online course. Online courses, also referred to as "Internet" or "Webbased" courses, offer students an excellent opportunity to pursue their educational goals at times and locations convenient to them. These courses are offered over the Internet, and do not require on-campus attendance.

The course content resides on the course delivery system WV ROCKS Web page. A textbook is required for reading assigned chapters and additional resources will be listed to enhance learning for the course. You can log in and do your courses work according to your schedule, as long as course deadlines are met. You will communicate with your instructor and classmates through the course communication tools: email, discussion boards, and perhaps chat sessions.

To enroll in this course you must have access to a computer with an Internet connection and an email account. A broadband internet connection is preferred. If you do not have a computer, public libraries and on-campus public use areas may be available for you to complete the course work. You will **NOT** be able to complete this course by using only an I Phone.

All assignments (discussion postings, quizzes, and essay questions) have individually designated deadlines for their completion, after which they will not be accepted. There will be no class meetings as such, since student mastery will be assessed through the completion of the discussion postings, quizzes, and essay submissions. However, there is no such thing as an inappropriate question. All students should feel free to join me on line doing officer hours, or use telephone or email me if you have any questions.

At the beginning of the course please familiarize yourself with the learning management system. Follow the get started instructions on the learning management system and take a systems tour. Next, read the course introduction and course syllabus that will detail the weekly assignments that include chapter readings, posting on discussion boards, quizzes and answering short essay questions. Details regarding these assignments will be explained later in the syllabus and posted on the delivery system. The grading system will also be detailed in the course syllabus.

Sometimes there are issues with internet connections. Please develop a back-up plan in the event your primary internet connection is down. Identify a secondary internet source in the event your primary internet connection develops a problem.

The course material will be presented in weekly modules, 1 through 8. The student week will consist of the hours from Sunday 11:59 p.m. hours until the following Sunday, 11:59 p.m. Each new week a learning module will be posted Sunday at 11:59 p.m. This weekly module will list the learning objectives, course material to be used and assignments for the week. All assignments must meet the deadline for all submissions on the following Sunday, at 11:59 p.m. At that time the assignment will be closed and next week's assignment will be open for submissions.

Each week the module will require the student to: read the assigned chapter and related content, an original posting to a discussion board, take the chapter quiz and answering the essay questions.

Be alert to the Sunday evening 11:59 p.m. deadline as late assignments cannot be accepted. This is an 8 week course and maintains a strict learning schedule. It is imperative you maintain the schedule for completion of these assignments as these assignments adhere to deadlines. Late assignments will not be accepted. Each week there will be three required assignments to complete. Each week the assignments will be available beginning on Sunday, 11:59 p.m. and you will have until the following Sunday, 11:59 p.m. to complete these assignments. Keep in mind it is better to complete to your assignments early in the event of internet disruption.

Each week you will post a response to a discussion question followed by a response to two other students' postings. Each week you will be required to answer an essay question that will be emailed to the instructor as an attachment. The third assignment is a chapter quiz. These assignments are which your final grade will be tabulated from.

Course description:

This course addresses the evolution and restriction of prisoner rights, custodial rights, civil liability and Section 1983 actions for violations of constitutional rights, excessive force claims, failure to train, failure to screen, deliberate indifference, medical care, civil liability and the use of force, civil liability for claims of failure to protect and for in police custody, prison conditions, liability and wrongful custodial deaths, liability issues surrounding searches and seizure issues and segregation, supervisor liability, and civil liability and the impact on corrections and law enforcement. Actions undertaken under the color of state law will be examined with scrutiny.

Course Goals and Objectives:

- Provide students with an explanation for trends in police and correctional litigation.
- Provide students with an explanation of civil and criminal liability potential of criminal justice personnel filed under federal statutes.
- Provide students with an explanation of general legal principles and standards that are applied under state tort law and the Federal Tort Claims Act.
- Provide students with an explanation of the historical development of a 1983 Federal Court action.
- Provide students with an explanation of potential liability issues for administrators in directing employees of criminal justice agencies.
- Provide students with a recognition of and identifying liability regarding failure to train.

- Provide students with an explanation of liability issues associated with personnel and employment.
- Provide students with the varying standards which apply to allegations of excessive force.
